## Gender Sensitive Parliament

# The Inter-Parliamentary Union (IPU) defines a GSP as:

Responding "to the needs and interests of both men and women in its structures, operations, methods and its work.

GSPs remove the barriers to women's full participation and offer a positive example or model of society at large."



### Research Question & Method

- Is Canada's Parliament more GS under Trudeau than Harper? If so, why?
- Hypothesis: 'Yes'
- 42 GS measures classified into 4 categories: (need to reduce these!)
- (1) Descriptive representation
- (2) Gender sensitive legislation
- (3) Gender sensitive parliamentary policies
- (4) Gender sensitive procedural framework
- Compare Trudeau's Parliament with Harper's along these 42 GS measure to assess if the GS of Parliament has improved (1), stayed the same (0), or gotten worse (-1) under Trudeau


